

Tuition Waiver for Dependents of Disabled and Fallen Service Veterans Winter 2020-2021 APPLICATION

In recognition of the service and sacrifices of military service personnel and their qualifying dependents, Rogue Community College (RCC) shall waive tuition **only** for the spouse and children of a qualifying veteran as **“last dollar”**. This means the student is only eligible for this tuition waiver if tuition is not fully covered by financial aid, state and federal grants, or scholarships. The waiver does not cover books, fees, or other expenses. The last dollar tuition waiver will be provided to the spouse and children who apply **prior** to age 24 (including adoptive and step-children) for all members of all branches of the United States Armed Forces or United States Coast Guard.

| The student must show proof of Chapter 35 Certificate of Eligibility. | | |

To receive this waiver, students must complete the following:

- The student **must** complete a FAFSA application and provide a copy of their RCC Financial Aid Award Letter or notification of non-eligibility to an RCC Veterans Coordinator.
- This tuition waiver **must** be filled out by the student and signed by an RCC Veterans Coordinator each term the student wishes to use it. Students are responsible for processing the form each term.
- This tuition waiver cannot be applied retroactively to any prior tuition charges and **must** be turned in, on or before the second Friday (01/22/2021) of each new term for consideration.
