



# Dual Enrollment by Term

Rogue Community College (RCC) and Southern Oregon University (SOU) have signed a consortium agreement (academic partnership) under which students *may* dual enroll at both institutions and have their combined credit load serve as a basis for establishing financial aid eligibility. Under this agreement, student financial aid eligibility will be processed by their "home institution" (the college where they have been officially admitted and maintain a majority of their term-by-term courses) using shared information from their "host institution" (the college where a student is also enrolled while attending their home institution).
