High School Diploma

- High school diploma
- Final high school transcript showing the date the diploma was awarded
- A copy of your “secondary leaving certificate” or similar document, if you completed high school in a foreign country

Recognized Equivalent

- General Educational Development (GED) Certificate or transcript
- A state certificate or transcript received after passing a state-authorized examination that the state recognizes as the equivalent of a high school diploma (not available in Oregon)
- An academic transcript that shows the student successfully completed at least a two-year program that is acceptable for full credit toward a bachelor’s degree
- A transcript and documentation that shows you excelled academically in high school but did not complete, if your state offers this option and you are pursuing at least a two-year degree

Homeschool

- A state credential for completing secondary school through homeschool (if your state required one)
- A transcript signed by your parent or guardian that lists your completed secondary school courses and includes a statement that you successfully completed secondary school through homeschool (if your state does not require a credential other than a diploma or recognized equivalent)

RCC may be able to accept other documentation to verify your high school completion status if the listed options are not available. Please contact Financial Aid Advising.
