Explanatory Notes for the category of “Other Uses of (a)(1) Institutional Portion  
Funds”

- Travel in response to COVID requirements are typically local mileage costs incurred by staff to obtain and deliver cleaning supplies or PPE.
- Increased ERP system implementation costs due to closure – the College found it necessary to purchase managed services beyond the original ERP Implementation scope of work. The inability to meet in-person and on-site to work through the implementation complicated processes and significantly impacted the ability to experience a successful outcome.
- As the College is self-insured for unemployment, there has been a significant increase in cost due to employees either furloughed temporarily or laid-off from active employment.
- Indirect – at the time of the award the College was in a Negotiated Indirect Cost Agreement of 44%, with a base of salaries and wages.
